

What is Screening?

Screening is a process for evaluating the potential presence of a problem.




What is an Assessment?



- An assessment is a process for defining the nature of the problem, determining a diagnosis, and developing specific treatment recommendations for addressing the problem or diagnosis
- Informs recommendations for further assessment, treatment intensity, treatment setting, and supportive services

Response to Screening for Alcohol Use



Options for Managing AUD

Behavioral health interventions

- Screening, Brief Intervention, and Referral to Treatment (SBIRT)
- Motivational interviewing
- Cognitive-behavioral therapy
- Mindfulness-based
- Contingency management
- 12-step facilitation
- Couples or family therapy

Food and Drug Administration (FDA)approved medication interventions

- Acamprosate
- Naltrexone
- Disulfiram

SBIRT is a framework based on "motivational interviewing" strategies

Requires coordination between clinical and operations staff to effectively implement.

There are **two key aspects** of the SBIRT process:

- Risk stratification
- Using Motivational Interviewing throughout each step of the SBIRT process for better outcomes

Tobacco, Alcohol, Prescription medication, and other Substance use (TAPS) Tool for Screening and Assessment

Screening

- Frequency of substance use in the past 12 months
- Positive or negative

Assessment

- Follows up on substance(s) with a positive screen
- Reviews substance use within the past 3 months

The Role of MI After A Positive Screening

- Engage
- Focus
- Empower
- Negotiate a plan



Summary

- Universal screening helps reduce stigma and normalize talking about alcohol use
- Treatment interventions may include a combination of behavioral health and medications, depending on the acuity and patient's readiness to change
- Follow-up on screening/assessment and interventions is key
